Mileage greater than 75 miles roundtrip from Dickinson, ND to the wedding and reception site will be charged at 55¢ per mile. Erickson Productions is not responsible for restrictions put on ceremony and reception sites. Erickson Productions reserves the right to use this production for promotional purposes. In the event that Erickson Productions has equipment failure, fees paid will be refunded. Footage is kept for six months and DVDs are guaranteed from defects.
